APPLY

- 2. Wet surface and surrounding area of stain with water. Do not apply cleaner directly on dry surface.
- 3. Do not allow product to dry on surface, keep wet.

SCRUB

- 4. Using rubber gloves and proper eye protection, generously pour RE over stain.
- 5. Scrub with a stiff bristle brush until dissolved.

RINSE

6. Immediately and thoroughly rinse area with water.

REPEAT

- 7. For stubborn stains, repeat steps as necessary.
- 8. SRW general purpose cleaners should be used prior to sealing.
